

ORDER OF ELECTION

STATE OF TEXAS

COUNTIES OF OLDHAM, DEAF SMITH & RANDALL §

WILDORADO INDEPENDENT SCHOOL DISTRICT §

WHEREAS, the Board of Trustees of Wildorado Independent School District (the "District") held a regular meeting on August 7, 2024, and that said meeting was open to the public, and public notice of the time, place and purpose of said meeting was given, all in accordance with Texas Government Code, Chapter 551.

NOW, THEREFORE, BE IT ORDERED BY THE BOARD OF TRUSTEES OF THE DISTRICT:

1. Elections shall be ordered to be held for Wildorado Independent School District on Tuesday, November 5, 2024, for three (3) at-large School Board Trustee positions.
2. Applications for a place on the ballot shall be filed with the District by August 19, 2024 at 5:00 p.m.
3. Pursuant to Texas Election Code §271.002, this election is hereby ordered to be held jointly with Oldham County, Deaf Smith County, and Randall County, and will be conducted by the election officials for each county pursuant to Election Agreements which may be approved by separate resolution.
4. The Early Voting Clerk for District voters residing in Oldham County is Darla Lookingbill. Oldham County resident voter applications for ballot by mail shall be mailed to Darla Lookingbill, Oldham County Clerk, PO Box 360, Vega, Texas 79092, or emailed to: elections@oldham-county.org.
5. The Early Voting Clerk for District voters residing in Deaf Smith County is Rachel Garman, Deaf Smith County Clerk. Deaf Smith County resident voter applications for ballot by mail shall be mailed to Rachel Garman, Deaf Smith County Clerk, 235 E. 3rd, Room 203, Hereford, Texas 79045, or emailed to: rgarman@deafsmithcounty.texas.gov.
6. The Early Voting Clerk for District voters residing in Randall County is Shannon Lackey, Randall County Elections Administrator. Randall County resident voter applications for ballot by mail shall be mailed to Shannon Lackey, Randall County Elections Administrator, P.O. Box 1654, Canyon, Texas 79015, or emailed to: electionadmin@randallcounty.gov.
7. Applications for ballot by mail (ABBMS) must be received no later than the close of business on October 25, 2024. Federal Post Card Applications (FPCAs) must be received no later than the close of business on October 25, 2024.

8. For all eligible District voters, early voting by personal appearance will be conducted on the dates and times and at the locations identified in Exhibit "A" attached hereto and incorporated herein by reference.

9. Voting on Election Day, November 5, 2024, for all eligible District voters will be conducted between the hours of 7 a.m. and 7 p.m. at the Oldham County precinct or Deaf Smith or Randall Countywide Polling Places listed in Exhibit "B" attached hereto and incorporated herein by reference.

10. The returns of said election shall be made to the Board of Trustees of the Wildorado Independent School District in accordance with the election laws of Texas. A copy of this Order, signed by the President and attested by the Secretary of this Board, may serve as proper Notice of Election. The President shall cause a Notice of Election to be given in accordance with said laws.
